Pure Water Southern California is currently undergoing a rigorous environmental review process. This process enables Metropolitan to identify and assess the program's potential impacts to local communities and our environment.

The public review and comment period is another opportunity for local communities, interested organizations and the public to participate in the environmental review for Pure Water Southern California.

What is the Draft EIR public review and comment process?

An EIR is an important document that helps inform the public and decision-makers about a project's potential environmental impacts and identifies ways to avoid, minimize or reduce those impacts. This public review and comment period provides an opportunity for community members and stakeholders to review the Draft EIR and submit comments on its adequacy. Your input can help ensure that the environmental analysis is thorough and considers potential impacts from construction, as well as from long-term operation of the new facilities.

What are the steps in the Environmental **Review Process?**

Completing the EIR environmental review process involves three steps, and each has opportunities for the public to get involved.



Draft EIR - The Draft EIR becomes available to the public for review and comment. Metropolitan will review all official comments and address them in the Final EIR. Please submit any public comments you may have on the Draft EIR by July 14, 2025.

Scoping - The types of environmental issues, questions and concerns to study in the

scope of the EIR are identified, based in part on the public input received during this

EIR. The scoping phase for Pure Water Southern California was completed in

phase. Ideas and perspectives shared at this stage inform the preparation of the Draft

Final EIR - After reviewing and addressing public comments on the Draft EIR, Metropolitan staff will prepare the Final EIR, which will then be considered for certification by Metropolitan's Board of Directors during a public meeting. Certification of the Final EIR is planned for 2026.
